2026 TERMS & CONDITIONS OF ENTRY

1. The entry must contain true and accurate information as to originality.
2. All entries must be of work completed in the period from 1 June 2024 to 23 July 2026.
3. Entries must be received by 5:00PM AEST Friday 24 July 2026. No late entries will be accepted.
4. The entry fee for ASGA current financial members is \$40 (incl. GST) per entry up to three entries received, then \$15 (incl. GST) per entry for the fourth and any subsequent entries.
5. General entries are required to pay a fee of \$40 (incl. GST) for each entry submitted.
6. A tax invoice will be forwarded in acknowledgement of receipt of entries. Entry will be confirmed upon payment of entry fees.
7. Entries into Category 20 - YOUNG STAR AWARD is free of charge.
8. It is important that on the Details section of your Online Entry you indicate the technical skills and craftsmanship you brought to the sign creation and the challenges met and solved. If you sub-contracted out any of the work, this must be noted in your entry.
9. Ensure that your entry:
 - Outlines the extent of originality in the work submitted for judging (ie, client supplied logos, clip art, sketches etc).
 - Details the title and category of the work entered and the name of the designer.
 - Lists the material, suppliers and the level of originality. If the work was not entirely completed in-house, list sub-contractors by job description that assisted on the project.

10. To ensure the integrity of the judging process, it is important that, as far as possible, the identity of the entrants cannot be determined in the work being judged when viewing the front face of the images. Therefore, promotional material, company-related personnel, business cards or graphics should not appear with the images of work entered. It is likewise important that photography does not include business signage or material in the background of any images to be judged that would enable judges to identify the entrant. **This includes ensuring the identity is not mentioned in any descriptions of the work.**
11. Identical entries may be submitted for judging in multiple categories, providing each separate entry gives major emphasis to the criteria of the particular category being entered. Changes in presentation format would need to illustrate this. In this or similar instances, a separate entry is required for each category entered.
12. Judging will be by an independent panel of industry professionals appointed by ASGA. The judges' decision will be final. The winner's scores are based on industry standard judging criteria and the collective decision of the independent judging panel. The judging panel will be given the discretion to make special mentions, if in their opinion, an entry is not technically correct. The judges may re-classify any entry, provided it does not disadvantage the entrant.
13. Each entrant authorises ASGA or any other delegated company or person to use any entry they have submitted for promotional or publishing purposes.
14. If insufficient entries are received in any category, the organisers reserve the right not to make an award in that category.
